The extensive use of indigenous plant species in new parks, waterway corridors, and streetscapes will have brought back many native birds and other wildlife, and created bushland that is valued by young and old. The well-designed and maintained landscapes will enhance the image of the municipality and will be managed for social, environmental and economic sustainability.

### Darlington's Open Space Strategy Vision

“To provide, protect and enhance a variety of high quality, accessible open and green spaces throughout the Borough, linking with the cultural and natural heritage of the area that are: well designed and maintained; sustainable; safe; and promote health, well being and enjoyment, improving the quality of life for residents and visitors to the Borough”

#### The Strategy's Aims

- to provide a sustainable amount of high quality, accessible open spaces across the Borough to meet the changing needs and expectations of local people, now and for the foreseeable future;
- to provide a variety of open spaces and facilities within them that, where appropriate, are equally accessible by all;
- to secure improvements in the design and management of open spaces, so that they are attractive and safe for everyone, their biodiversity is enhanced, and the Borough's distinctive history and culture is conserved;
- to build and sustain strong relationships with the local community and other agencies to help shape change on open spaces.

The **action plan** of the Darlington's Open Space Strategy is designed in a table and presented in the appendix of the strategy. The actions are organised and sorted by the four major strategic aims and 12 sub aims. These are the following:

**AIM 1:** to provide a sustainable amount of high quality, accessible open spaces across the Borough to meet the changing needs and expectations of local people, now and for the foreseeable future;

- Protect existing valued open spaces
- Address quantitative deficiencies in open spaces
- Secure qualitative improvements to existing open spaces
- Periodic review of open space supply against demand

**AIM 2:** to provide a variety of open spaces and facilities within them that, where appropriate, are equally accessible by all;

- Address areas of deficiency on a geographical basis
- Increase the amount of public use of existing open spaces
- Improving the accessibility of sites, e.g. footpath links, new entrances

**AIM 3:** to secure improvements in the design and management of open spaces, so that they are attractive and safe for everyone, their biodiversity is enhanced, and the Borough's distinctive history and culture is conserved;

- Enhance existing open spaces
- Introduce sustainable management practice and the promotion of biodiversity across a

wider range of open spaces

**AIM 4:** to build and sustain strong relationships with the local community and other agencies to help shape change on open spaces.

- Involve local people in the management and maintenance of parks
- Engaging with local people to develop responsibility/ownership of their local environment
- Ask local people for their views and respond to them

The 57 actions are briefly characterised under the following five column headings: Action, Timescale, Key Milestone, Funding, and Lead Officer/Agency. The action plan is prepared for the time range of five years, from 2007 to 2012 where a timescale of a short term action indicates 1-2 years, a medium term action 3-5 years and long term action 6-10 years.
